All materials within the scope of the course, an online pattern construction class and drafting literature are included in the course fee. Expense for travel, accommodation, sustenance and taxes are the student's responsibility.

### Syllabus

The course delivers fundamental pattern construction and tailoring techniques, applicable to both men's and women's jackets. The course teaches the construction of a bespoke tailored jacket, using the same traditional techniques as taught on the regulated Level 5 Diploma course, the highest level of tailoring tuition in the UK. Over 20 days, with 150 hours of tuition in total, students will learn to make a full scale jacket for themselves.

Students are required to use information technology to facilitate their learning. A tablet computer and headphones are provided.

### Student Wellbeing

To ensure the maintenance of a creative and positive learning environment and the successful delivery of the course, students are expected to maintain excellent attendance, timekeeping and organisational skills. ## General Terms and Conditions

These terms and conditions shall govern the course offering and provision specified herein above by the applicant specified herein above (hereinafter "Student") and the Tailoring Academy Ltd (hereinafter "TA").

1. Services: TA shall provide the services outlined above during the times and with the content indicated ("Services") to the Student in accordance with these terms and conditions. The Student is responsible to ensure the right of visiting the United Kingdom during the term of the Services. Certification will be provided as appropriate.

2. Remuneration: As consideration for the provision of the Services the Student shall pay the course fees as set out above. If the Student stops attending the course for any reason other than for good cause (such as, by way of example, inability to attend due to a sustained change of their capabilities caused by an accident or serious long-term illness), the entire outstanding balance of the fees shall become due and payable immediately. The method of payment of the fees shall be by BACS to TA's account which shall be provided to the Student. Any charges payable under this Agreement are inclusive of VAT but exclusive of other taxes, tariff surcharges or other like amounts assessed by any governmental entity arising as a result of the provision of the Services by TA to the Student under this Agreement and such shall be payable in addition to all other charges payable hereunder.

3. Term & Termination: This agreement shall commence on the date signed by the Student and remain in force until the last day of the Services as indicated. Each Party shall be entitled to terminate this Agreement with immediate effect by notice to the other party upon the occurrence of any of the following events, each of which shall be deemed a material breach of this Agreement: (i) material breach by either party (which, in the case of the Student, shall include non-attendance without good cause for 7 calendar days or more); or (ii) bankruptcy of the other party or the other party's discontinuation of its business. TA reserves the right to withdraw offering the Services at any time. In this case, all fees shall be returned to the Student pro rata temporis, unless such withdrawal is due to force majeure or other circumstances beyond TA's reasonable control.

4. Confidentiality and Non-Disclosure: The Student acknowledges that, in the course of the performance of this Agreement, they will obtain confidential information or materials from the TA, without limitation, underlying literary material, creative elements, guides, specifications and processes or other technological developments. The Student shall, at all times both during the term of this agreement and thereafter, keep all of TA's confidential information in confidence and trust. The Student shall not use such confidential information other than as expressly permitted herein or by prior approval. Use for the Student's own endeavours is permitted. However, the commercial use is prohibited. The Student acknowledges that any breach of the foregoing may cause irreparable injury to TA not readily measurable in monetary amounts; consequently, TA shall, without waiving any other rights or remedies, be entitled to injunctive and/or declaratory relief in connection with any breach or threatened breach hereof.

5. Notices: Notices hereunder shall be given in writing and sent by registered or certified mail, return receipt requested, or by e-mail, or nationally recognised express carrier, addressed to the respective party at the address indicated in the Agreement. Each party shall notify the other in writing promptly of any change in address.

6. Governing Law & Jurisdiction: The parties hereby irrevocably and unconditionally agree that this Agreement and the validity hereof shall be governed exclusively by and construed in accordance with the laws of England excluding any principle or provision of private international law which would but for its exclusion abrogate the application of English law. The parties agree to the exclusive jurisdiction of the ordinary courts in England.

7. General Provisions: This Agreement shall not be changed, amended or modified unless in writing signed by an authorised signatory of both parties hereto. This Agreement is personal to the parties and the Student shall not assign any of its rights hereunder or transfer any of their obligations to a third party. The parties are independent contractors under this Agreement and no other relationship is intended, including a partnership, franchise, joint venture, agency, employer/employee, fiduciary, master/servant relationship or other special relationship. Neither party shall act in a manner which expresses or implies a relationship other than that of independent contractors. A person who is not a party to this Agreement shall have no right under the Contract (Rights of Third Parties) Act 1999 to enforce the terms of this Agreement and the parties expressly agree that the terms of such legislation shall not be applicable to this Agreement. TA shall not be liable for delays or failures in performance arising from causes beyond its reasonable control, including, but not limited to, force majeure, labour disputes or disturbances, material shortages or rationing, pandemics and other events concerning public health, riots, acts of war, governmental regulations, communication or utility failure or casualties and similar events. If any provision of this Agreement is held to be invalid or unenforceable by any judicial or other competent authority, all other provisions of this Agreement will remain in full force and effect and will not in any way be impaired. If any provision of this Agreement is held to be invalid or unenforceable but would be valid or enforceable if some part of the provision were deleted, the provision in question will apply with the minimum modifications necessary to make it valid and enforceable.
